a. Gilmore Rear Setback Variance Request

Property located at 753 Malbec Road, Applicant is requesting a Variance for a Rear Setback reduction from 25' to 20' to allow for the placement of a swimming pool. Rescheduled to May 12, 2020

- b. <u>Free Falling Properties, LLC Rezoning Request from R-1, Residential to C-2, General Commercial</u>

 Property located at 2058 Steele Road Containing 14.39 acres more or less. Rescheduled to May 12, 2020
- c. <u>Andrew Fields, Request to fill Ravine and approval to build a fence higher than 36 inches</u>

 Property located at 1991 Steele Road Containing approximately 5 acres.

Mr. Fields is requesting approval to fill in a ravine on his property with tree cuttings, tree trunks, fill dirt and other approved materials, so he can have more useable land. Mr. Fields agrees to fill and cover every two weeks until completely filled, estimated time is one year.

At this time the Planning Board agreed to allow Mr. Fields to request to build a fence higher than 36 inches but will not exceed six foot. The fence will be a pipe or a wood rail fence (not a privacy fence).

Gene McCartney has no abjection to these requests or the time frame as long as the fill is monitored and kept clean.

d. Hampton Holdings LLC, Final Plat South Pointe Phase II
