Venezia Piazza Phase II.

PROJECT SYNOPSIS:

The Venezia Piazza Phase II Vacation request is to vacate a portion of unused Utility and Drainage Easement and to realign an access easement to better align with the stubout to the East on the La Hacienda property.

§ 152.028 VACATION OF STREET RIGHT-OF-WAY, EASEMENTS OR ALLEYS.

- (A) Application for easement/alley vacution. The application shall be submitted to city staff pursuant to the filing schedule approved by the Planning Commission and shall consist of the following:
- (1) Application. Completed and signed application form as provided by the appropriate city official or city staff.
 - (2) Fee. Pay the filing fee specified in the application forms.
 - (3) Petition. A petition to vacate street right-of-way, alley or easement.
- (4) Consent for property owners. Written consent of all property owners abutting the street right-of-way, alley or easement to be vacated.

- (5) Ownership. Proof of ownership of all property abutting the street right-of-way, alley or easement to be vacated.
- (6) Consent from utilities. Written consent from all utilities affected by street right-of-way, alley or easement to be vacated.
- (B) Review and approval. The appropriate city staff will review the request and recommend approval or denial of the request for a vacation. The City Council shall make the final determination on approval of vacations by adopting an ordinance stating that the legal description as provided by the applicant, and verified by the city, is vacated. (Ord. 2013-04-417, passed 4-2-13; Am. Ord. 2013-09-440, § 152.300.06, passed 9-3-13)

STAFF ANALYSIS: The Applicant has submitted all of the completed and signed forms required by the Code. The adjoining Neighbor to the East (La Hacienda) has consented to the Vacation and realignment of the Access Easement. All utilities have consented to the Vacation of the Utility Easement. The Grading and Drainage Plan has been sent to the City Engineer to review prior to Construction Plan approval for the Large Scale Development.

This property accesses E. Henri de Tonti Blvd. and S. Maestri. The realigned access easement will help with cross connectivity between La Hacienda (neighboring property to the east) and S. Maestri to the West.

Fire:

No concerns were submitted for the requested vacation.

Police:

The Police Chief has no concerns for the requested vacation.

STAFF RECOMMENDATION: Staff finds the requested Vacation has met all of the requirements within our City Code and recommends approval with the following conditions. This Vacation will be required to be approved by the City Council if the Planning Board chooses to recommend its approval.


CONDITIONS RECOMMENDED FOR APPROVAL:

- 1. A legal description of the new Access Easement must be written and approved.
- 2. The Black Hills Energy 2" Distribution gas pipeline located in the northwest corner of said tract is retained to include said pipeline.
- 3. A separate Easement Plat shall be signed and filed with the Circuit Clerk's Land Records Office.


