A RESOLUTION EXPRESSING THE WILLINGNESS OF THE CITY OF **TONTITOWN** TO UTILIZE FEDERAL-AID SURFACE TRANSPORTATION BLOCK GRANT PROGRAM- ATTRIBUTABLE **FUNDS** ADMINISTERED \mathbf{BY} THE NORTHWEST ARKANSAS REGIONAL PLANNING COMMISSION FOR A PROJECT CONSTRUCT A TRAFFIC SIGNAL AT THE INTERESECTION OF U.S. HIGHWAY 412 AND KLENC ROAD IN THE CITY OF TONTITOWN. ARKANSAS.

WHEREAS, the City of Tontitown understands Federal-aid Surface Transportation Block Grant Program Funds are available at 80% federal participation and 20% local match to construct a traffic signal at the intersection of U.S. 412 and Klenc Road; and

WHEREAS, the City of Tontitown was previously awarded \$360,000.00 in the year 2020 to fund the project; and

WHEREAS, the City of Tontitown is requesting additional construction funds in the amount of \$501,500.00 in order to complete the project; and

WHEREAS, the City of Tontitown understands that Federal-aid Funds are available for this project on a reimbursable basis, requiring work to be accomplished and proof of payment prior to actual monetary reimbursement; and

WHEREAS, the City of Tontitown understands that there will be no reimbursement for any work accomplished prior to issuance by the Arkansas Department of Transportation of an official notice to Proceed; and

WHEREAS, this project, using federal funding, will be open and available for use by the public; and

WHEREAS, the City Council has determined that it is in the best interest and benefit of the community to utilize Federal-aid Surface Transportation Block Grant Program Funds to construct a traffic signal at the intersection of U.S. Highway 412 and Klenc Road.

NOW, THEREFORE, BE IT RESLOVED, by the City Council of the City of Tontitown, Arkansas:

- Section 1. The City of Tontitown will participate in accordance with its designated responsibility.
- <u>Section 2.</u> The Mayor of Tontitown is hereby authorized and directed to execute all appropriate agreements and contracts necessary to expedite the construction work for the above stated project.
- <u>Section 3.</u> The City Council of Tontitown pledges its full support and hereby authorizes the City of Tontitown to cooperate with Northwest Arkansas Regional Planning Commission.
