A RESOLUTION TO WAIVE COMPETITIVE BIDDING AND AUTHORIZE THE PURCHASE OF ONE (1) 2024 CHEVROLET TAHOE AND RELATED EQUIPMENT FOR THE TONTITOWN POLICE DEPARTMENT.

WHEREAS, the City Council has determined that it is in the best interest and benefit of the community to authorize the purchase of one (1) 2024 Chevrolet Tahoe and related equipment for the amount of \$53,450.00, attached hereto as Exhibit "A" from Fayetteville Autopark for the Tontitown Police Department, and to waive competitive bidding for the same.


