On or about September 19, 2023, the City Council passed Ordinance No. 2023-09-1074 which enacted water and wastewater impact fees and adopted rules and regulations related thereto for the City of Tontitown, Arkansas, and the adopted rates in Ordinance No. 2023-09-1074 reflected an amount equivalent to 25% of the maximum amount allowed by the impact fee study that was adopted by the City Council.
